**Discussion:** Revenue is higher than anticipated by approximately \$250,000.00. We are holding below projected expenditures – part of that being short two SSAs earlier this year, and now down to being short one SSA salary. Interviews for that remaining position begin next week. Recent attendance at the Superintendent Executive Committee revealed that Paulding County lost \$414,000.00 in subsidy cuts between 2014 and 2018. This number is just under what The Board is asking on the renewal levy.

## Reports

**Superintendent:** October 24<sup>th</sup> is the Always There Statehouse Celebration. Deb, Krystal Albright, and her mother Nancy will be representing Paulding County at this event. Deb attended the Synergy Conference the first week in October, along with SSA Crystal Feeney, PCW staff Chantel Lehmkuhle, and 3 self-advocates. The conference gave our individuals the opportunity to attend training sessions, as well as meet new friends around the State of Ohio. Deb will be attending the Paulding County Economic Development Business Industry Appreciation Banquet this evening at Grant's Catering. The Annual OACB Delegate meeting will be held on Wednesday evening, November 29<sup>th</sup> in Columbus. The Board will need to appoint a delegate to represent Paulding County. The finance committee will need to meet to draft a proposed appropriations budget to submit to the Board, prior to submitting to the Commissioners. We will need to meet before our November Board meeting, which is Nov. 16. Levy updates: I presented at the Chamber Candidates and Issues Breakfast on Oct. 3 and the Antwerp Rotary on Oct. 12. Both presentations went very well. I have the following presentations scheduled: Oct. 23 at VanCrest Nursing Home in Antwerp, Oct. 31 at Paulding Senior Center, and Nov. 2 at Paulding Kiwanis.

**SSA/Shannon Timmerman:** 28 IO Waivers. 6 SELF Waivers, 23 Level 1 Waivers, 2 Adult Services, 9 Case Management Only, 19 Children (No Waiver). 14 Individuals are currently community employed. This number includes those individuals that work for the PC Workshop Roadside Cleaning Crew and Garages. Paulding County received a total of 10 State Funded Waivers – 5 SELF Waivers, 3 Shared Living IO Waivers, and 2 Regular IO Waivers. All slots have been enrolled. There are a total of 31 on the Wait List. The total number accounts for 23 individuals as several individuals are on multiple lists. Many of these individuals are children or are individuals already enrolled on a smaller waiver. The SSA Department is identifying those with priority needs. A new wait list rule is being developed so we have been following that closely in order to determine how it will affect our waitlist.
