Superintendent:

- Housing Board- County Boards are permitted to use or create a nonprofit corporation that is granted 501(c) 3 status by the IRS. The nonprofit board would be specifically chartered to develop, acquire, and manage permanent affordable housing for individuals. County Boards may use Community Capital Assistance Funds to acquire housing for individuals receiving supported living services in the community.
- Strategic Plan County Boards are required to develop and adopt by resolution a strategic plan that includes the Board's mission and vision, and addresses the strategy for promoting self-advocacy by those served by the Board through person centered planning process, activities, and community connections; ensuring that individuals receive services in the most integrated setting appropriate to their needs; reducing the number of individuals on the county's waiting list, increasing the number of working age individuals engaged in community employment; taking measures to recruit sufficient providers of service; and meet with each newly certified provider within 60 days of the provider being selected to provide services. The plan must be made readily available to the community. The Board must prepare a progress report at least once per year. The Board must have a mechanism for accepting feedback on the plan and progress.
- Levy campaign Billboards will go up in October. Three locations have been secured. We are trying to
 obtain a 4th. One will be a "vote yes". The others will feature individuals and their services. We are working
 on finalizing plans for the pulled pork fundraiser on October 18. Developing fact sheet to share with public.
