Reports

Early Intervention:

- We are currently doing a few once a month face to face sessions with families. This is determined by the
 team and is evaluated on a case by case discussion. Every family is receiving Zoom/Virtual sessions when
 they are not getting the face to face.
- There are currently 29 enrolled, 2 pending, and 2 referrals.

SSA Supervisor

- Four SSA's providing service coordination services to a total of 96 individuals. Average caseload size is 24 individuals. We recently changed to a weighted caseload model.
 Three intakes are currently in progress.
- Brittco: This past year we started using Brittco Software to enter TCM. We are diving into using the forms, caseload and calendar features of the system.
 - SSA's have been very busy updating ISP's due to the changes caused by COVID 19. They are keeping in contact (phone, video, etc) with individuals to ensure health and safety. They are working with providers to identify those ready to safely return to day services.

Superintendent:

 PC Workshop Adult Day Service provider is reopened for services. There are limitations on the number of individuals per setting.

- Early Intervention is conducting some face to face visitations. Visits are determined on a case by case basis after consultation with families.
- Paulding CBDD continues meeting with providers on a monthly basis. This provides the opportunity to hear
 from providers regarding challenges they may be encountering. Identifying these challenges gives the Board
 an opportunity to assist where possible.
- This is Direct Support Professional Appreciation Week. We have delivered 50 yard signs expressing the Board's appreciation.
