# Superintendent:

- OACB will hold the Annual Convention virtually this year via the Zoom platform. Convention dates will take
  place over a three-week period. Week 1: November 17-19; week 2: December 1-3; and week 3: December
  8-10. A catalog with session information will out soon. If any Board member is interested in registering for
  conference sessions I will help with the registration.
- October is Disabilities Employment month. We are using Billboards and social media to recognize employees as well as employers in the community.
- With the pandemic causing the Adult Day Service providers to discontinue services for several months there
  a subsequent loss of revenue for those providers. Additionally, when reopening there were limitations on the
  number of individuals permitting in a setting. Again, this created financial stress on that part of our system.
  DODD permitted providers to bill at a higher reimbursement rate through the end of September to help offset
  the losses created by these factors. DODD extended the inflated reimbursement rates through the end of
  the calendar year.

#### **SSA Supervisor:**

Currently there are 97 individuals being served, 2 intakes in progress, and 2 transfers in from other counties.
There are 58 currently enrolled on waivers and 4 on the allocation list for next year. The department is down
to 2 on the transitional waitlist. SSAs continue with trainings and education on multisystem and social
security and are continuing plan updates and revisions.
